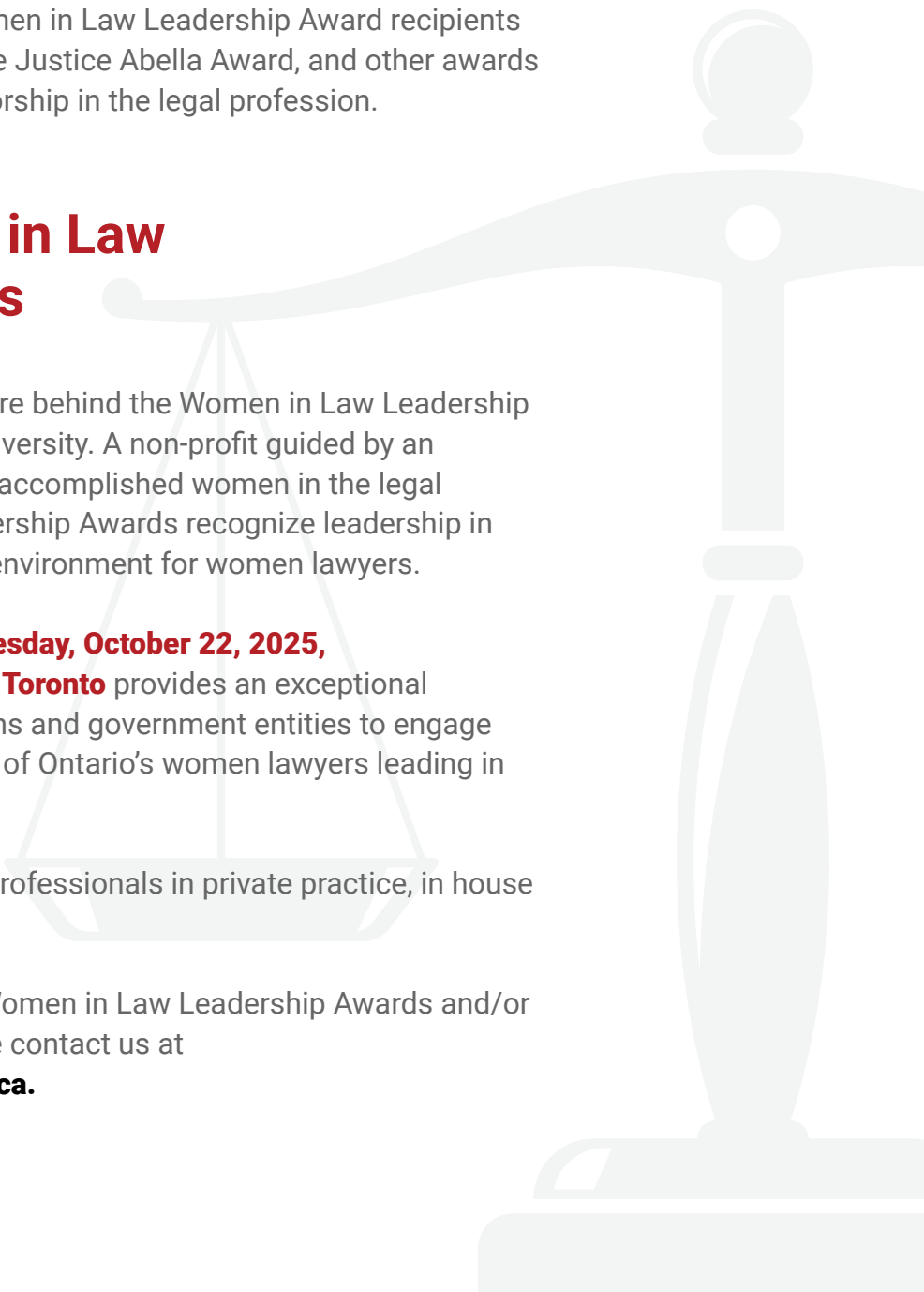
About the **Women in Law Leadership Awards**
